**Ingestion:** continue flushing for several additional minutes. If effects occur, consult a physician, preferably an ophthalmologist. If swallowed, seek medical attention. #### 5. FIRE-FIGHTING MEASURES

fine water spray or foam. Cool surroundings with water to localize fire zone. Hand held dry chemical or carbon dioxide extinguishers may be used for small fires.

**Other information:**
